4. **I shall not engage in violence, intimidation, threats, hate speech, discrimination, bribery, voter manipulation or any other unlawful or unethical conduct** during the electoral process.
5. **I shall respect my fellow Party members and candidates**, and shall conduct my campaign with dignity, fairness, discipline and respect for the law.
6. **I shall support and campaign for the duly nominated candidates of the Wiper Patriotic Front** and shall work towards the success of the Party and its candidates at all levels.
7. **I shall not defect from, campaign against, or publicly undermine the Party** or its officially endorsed candidates during the electoral period, except in accordance with the Party Constitution and applicable law.
8. **I shall abide by lawful directives and decisions of the Party organs** and shall cooperate with the Party leadership, National Elections Board and relevant Party structures in the implementation of the Party's electoral programme.
9. **I shall uphold the principles of good governance, integrity, accountability, transparency, inclusivity, service to the people and respect for the Constitution of Kenya.**
10. **I shall use the Party's name, symbols, colours, logo and other official materials responsibly** and only in accordance with the Party's authorised guidelines.
11. I undertake that **I shall not use public resources, Party resources or any other resources unlawfully** for purposes of my campaign or personal political benefit.

12. I understand that **my nomination is a position of trust and responsibility**, and I undertake to represent the Party and the people with honour, discipline and integrity.
13. I acknowledge that **breach of this Oath, the Party Constitution, Party Code of Conduct, nomination rules or applicable electoral laws** may result in disciplinary action by the Party and/or any other lawful action as provided by law.
14. I undertake to **place the interests of the people, the Party and the nation above personal interests** and to uphold the Party's principle of:

"ONE PEOPLE, ONE NATION."
